Independent assessment from Safetycare NZ Limited

We have done an independent assessment on the management and disposal of sanitary waste here in New Zealand and any risks to users of the Pod™ Petite system.

We looked at guidelines from the Ministry of Health, Ministry for the Environment, Worksafe NZ and Regional/City Council waste management requirements.

It is clear that sanitary waste (e.g. feminine sanitary pads/tampons) collected from the general public is permissible in general waste to landfill. It is not classified as hazardous waste.
